8(a) STARS II | SUMMARY

The 8(a) Streamlined Technology Application Resource for Services II (STARS II) Governmentwide Acquisition Contract (GWAC) is a Multiple-Award Indefinite-Delivery Indefinite-Quantity (IDIQ) contract to provide information technology (IT) services and IT services-based solutions which may include the integration of ancillary support, a necessary and integral component to the IT services being acquired. STARS II is reserved for qualifying Small Business Administration certified 8(a) prime contractors with competitive prices.

8(a) STARS II | HOW TO USE

Any Federal Government agency may use STARS II. Contracting Officers must complete a short training course and obtain a delegation of procurement authority (DPA) prior to issuing task orders on the contract.

The STARS II (GWAC) provides agencies with the ability to award directed task orders in the following functional areas (FA) to meet your mission needs:

- 541511 - Custom Computer Programming Services
- 541512 - Computer Systems Design Services
- 541513 - Computer Facilities Management Services
- 541519 - Other Computer Related Services

8(a) STARS II industry partners are classified in two constellations. Industry partners in both constellations have competitive pricing and technical proficiency. Constellation II also includes industry partners with an additional industry credential, such as Capability Maturity Model Integration (CMMI) or ISO 9001 (quality management system).

8(a) STARS II | FEATURES

- \$10B program ceiling and five-year base period with one, five-year option
- Directed task orders up to \$4M with multiple-year timeframes
- Other direct costs procurement permitted when considered necessary to the IT effort
